# **PURPOSE**

The purpose of this policy is to establish controls to ensure compliance with all applicable **General Data Protection Regulation** (EU) 2016/679 and to ensure that the Company's business is conducted in a socially responsible manner.

# **GENERAL DATA PROTECTION REGULATION**

The General Data Protection Regulation (EU) 2016/679 (GDPR) is a regulation in EU law on data protection and privacy in the European Union (EU) and the European Economic Area (EEA). The GDPR is an important component of EU privacy law and of human rights law, in particular Article 8(1) of the Charter of Fundamental Rights of the European Union. It also addresses the transfer of personal data outside the EU and EEA areas.

The GDPR's primary aim is to enhance individuals' control and rights over their personal data and to simplify the regulatory environment for international business. Superseding the Data Protection Directive 95/46/EC, the regulation contains provisions and requirements related to the processing of personal data of individuals (formally called data subjects in the GDPR) who are in the EEA and applies to any enterprise—regardless of its location and the data subjects' citizenship or residence—that is processing the personal information of individuals inside the EEA.

When we process personal data of UK residents we are subject to the General Data Protection Regulation ((EU) 2016/679) (UK GDPR), the Data Protection Act 2018 (DPA 2018) and the Privacy and Electronic Communications Regulation (PECR) and when we process personal data of non-UK data subjects we are subject to the General Data Protection Regulation ((EU) 2016/679) (EU GDPR) and the PECR which applies across the European Union and we are responsible as 'controller' of that personal information for the purposes of those laws.

It is important that you read this GDPR Compliance policy together with any other privacy policy we may provide on specific occasions when we are collecting or processing personal data so that you are fully aware of how and why we are using your data. This privacy policy supplements other notices and privacy policies and is not intended to override them.

We do not collect Special Categories of Personal Data. If you fail to provide personal data Where we need to collect personal data by law, or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter with you (for example, to provide you with goods or services).

In this case, we may have to cancel a product or service you have with us, but we will notify you if this is the case at the time.

- We will not ask you for your address

# How we handle your personal data

We do not share your personal data and information with third parties for marketing purposes.

We process your personal data when it is in our reasonable interests to do this to provide our services.

We will not, and do not sell, distribute or lease your personal information to third parties.

You may choose to restrict the collection or use of your personal information

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

# Your rights

You have the right to request:

- ask that the processing of your personal data is restricted in certain circumstances
